8.2 <u>Business With Notice - Cr Karsten on behalf of Cumbalum Residents</u> <u>Association (CRA) - Ballina Heights Shopping Centre Delays</u>

On behalf of CRA, Cr Karsten raised the delays for the Ballina Heights Shopping Centre which came up as part of the 8.2 LEP updates at the last Ordinary meeting.

The following update was provided at the meeting.

Key concerns raised by residents:

The applicant provided the residents the following sequence of correspondence between the developers and Council:

- Application formally received by Council 15/09/2023
- Additional Information was requested 5/10/2023
- Additional Information was provided 18/10/2023
- Additional Information was requested 3/11/2023
- Additional Information was provided 24/11/2023
- Additional Information was requested 11/09/2024
- Additional Information was provided 11/10/2024

Of note is provision of information on the 24/11/23 (the second lot of info requests made by Council staff) and a subsequent 10 month delay of response from Council asking for additional information. Also of note is additional information being provided on the 11/10/24 and the approval only taking place an entire year later.

Staff comment:

At the time this development application was lodged, Council had a very high volume of new and undetermined development applications coupled with a number of development assessment staff vacancies. To help progress this application, Council engaged an external consultant to assist with the assessment of the application.

The additional information requested of the applicant by Council (including the engaged consultant) related to numerous substantial issues including:

- Clarification around aspects of the proposal and design
- Updated plans and documentation to address relevant statutory planning provisions
- Address of traffic impacts, including traffic generation, external volumes, impact analysis, access to the site, internal circulation, public transport

access and pedestrian linkages and pathways to the site from surrounding land

- Car parking assessment
- · Accessibility for people with a disability
- Noise impacts
- Stormwater management, modelling, points of discharge
- Bulk earthworks details and relationship to surrounding land
 Of importance to note is that Council issued further follow on
 correspondence to the applicant on 29 January 2024 in relation to
 engineering issues concerning traffic management, earthworks and
 stormwater management. Responses from the applicant were received
 on 8 April 2024.

Unfortunately, the external consultant who had been assessing the application could no longer continue to do so, and a new consultancy was engaged. This took some time for the new consultant to come up to speed on the development details and the status of the technical assessment.

The final correspondence was issued to the applicant on 11 September 2024 relating to matters including car parking assessments, traffic impacts and the Traffic Committee comments and accessibility matters raised by Council's Access Reference Group.

The applicant responded in part on 11 October and on 21 October 2024.

A draft assessment of the development application was completed by January 2025. Following this, further discussions between the applicant and council continued particularly focussed on developer contributions and car parking requirements. The applicant submitted additional information in June 2025 in the form of a catchment analysis of the impacts of the traffic generation on the surrounding road network.

Council subsequently commissioned an external review of this catchment analysis. Following receipt and examination of this review, council proceeded to complete its assessment of the development application and a Notice of Determination (consent) was issued on 10 October 2025.

The information provided at the meeting was noted.

8.3 <u>Business With Notice - Cumbalum Residents Association (CRA) - Developer Contributions Reduction Request, Cumbalum Shopping Precinct</u>

In relation to DA 2023/270 for the retail shops at Cumbalum, which has recently been approved with a \$900K Council contribution, Cumbalum Residents Association (CRA) understand the developers are seeking to reduce their contribution to Council. We are concerned this will further delay the commencement of the commercial development, which Cumbalum residents have been expecting for over a decade. Can Council staff please comment on whether this amount is customary for the size and scope of this development, provide an example of a recently approved similar sized development (such as the shops at Epic estate) and what contributions were sought for those

developments, and explain why, to your understanding, the Ballina Catholic Parish would be disputing the amount sought by Council?

At the meeting the following information was provided.

DA 2023/270 is for Stage 1 of the commercial development with 11 retail tenancies and has contributions of \$934,552.42 (approx. values s7.11 Roads \$720k, Rous Water \$127k, Sewer \$76k, Water \$11k).

DA 2023/535 (TBD) is for stage 2 for the supermarket and bottle shop. This DA is not yet determined but could have contributions of approximately \$590,000.

The contributions and charges amount is based on the increase in demand on infrastructure attributable to the proposed development. For this type of commercial development, it is generally based on the new floor areas (GFA).

In comparison, the EPIQ shopping centre at Lennox Head (DA 2017/447) paid about \$3m in contributions and charges, which is commensurate with it being about double the size of this development.

The applicant raised concerns as to the amount, and council replied that the s7.11 contributions and s64 DSP charges are in accordance with Councils adopted plans.

It is unclear why the applicant is disputing the assessment by Council, however their consultants have indicated this site should be treated differently as the development has a minor increase on demand over the existing situation due to its location.

The information provided at the meeting was noted.

8.4 <u>Business With Notice - Cumbalum Residents Association (CRA) - Campbell's Common Pond Maintenance</u>

At the September A Ward Committee meeting Council were informed that 2/3 of the pond is encased in weeds, enveloping the water, becoming an eyesore and reducing bird species, even though Council has a Biodiversity Strategy which suggests an interest in keeping important habitats intact. The response was that Council were assessing all ponds across the Shire, with no timeframe given. What is the current update on de-weeding the pond, which continues to be neglected?

At the meeting the following information was provided.

The process of inspecting and programming maintenance works for Council's stormwater basins is ongoing and it is expected that this will be completed prior to the end of the year. Based on the work completed so far it is anticipated that much of the work required can be completed with Council's internal maintenance crews (noting that the staff resourcing/availability will govern the ultimate program timeframe).

Council Officers have inspected Campbell's Common Pond and the total program of these works is still uncertain .

Minor vegetation maintenance works around the viewing platform and the maintenance access entrance has been completed. Further vegetation clearing will be completed later this week to improve visibility and access to the site, allowing the project team to accurately assess and confirm the scope of remaining tasks.

However, this work does not address the broader issue of vegetation growth across wetland itself which is an exercise that is anticipated to be costly and may require environmental approval and contractor involvement. The removal of this vegetation is not required from a stormwater management perspective and is considered primarily an amenity issue.

The information provided at the meeting was noted.

8.5 <u>Business With Notice - Cumbalum Residents Association (CRA) - Update on Construction of Additional Culverts on Deadmans Creek Road, Cumbalum</u>

The CRA would like an update on the building of additional culverts on Deadmans Creek near Summerhill Drive to reduce flooding.

At the meeting the following information was provided.

Council are planning on closing the section of Deadman's Creek Road between Tamarind Drive and Summerhill Crescent from next Tuesday (18 November) to next Friday (21 November) to allow for the drainage works to happen.

Proposed works include installing a twin set of culverts near the corner with Summerhill Crescent where water has been pooling and to clear out the drains along Deadman's Ck Rd.

We will have a flail mower out on Deadman's Creek Road with traffic control on Monday (17 November).

Please see the map below (blue polygons show the drains to be cleaned and red lines show the location of culvert installation).

TREES HAVE ALREADY FALLEN INTO THE CREEK AND MORE ARE ABOUT TO. BUSES TRAVEL ALONG THE ROAD TO THE HALL FURTHER UP THE ROAD.

AT THE MEETING THE FOLLOWING INFORMATION WAS PROVIDED.


ALONG THE RICHMOND RIVER AND ASSOCIATED TRIBUTARIES THERE IS A SIGNIFICANT PERCENTAGE OF EXISTING OF ROCK REVETMENT IN A POOR CONDITION. MOST OF THE ROCK REVETMENT IN OUR URBAN AREAS IS ALONG CROWN LANDS AND IS CROWN'S RESPONSIBILITY TO MANAGE THESE REQUESTS.

TO MANAGE REQUESTS THAT FALL UNDER COUNCILS RESPONSIBILITY, EACH SITE IS PRIORITISED ON RISK TO PUBLIC INFRASTRUCTURE AND URBAN FORESHORE.

THE SECTION OF SMITH DRIVE YOU HAVE HIGHLIGHTED IS COUNCIL'S RESPONSIBILITY. THIS SITE WILL REQUIRE REMEDIATION WORKS TO MAINTAIN THE ROAD SHOULDER AND ELIMINATE THE RISK OF FUTURE DAMAGE. THIS HAS BEEN INSPECTED BY THE ENGINEERING WORKS TEAMS AND THE TEAM ARE COMPLETING PRECONSTRUCTION ACTIVITIES TO REPAIR THIS SECTION.

ACTION: CIVIL SERVICES TO PROVIDE AN UPDATE AT THE 10 MARCH 2026 MEETING.


THE FOLLOWING INFORMATION WAS PROVIDED AT THE MEETING.

ACTION: CIVIL SERVICES TO PROVIDE AN UPDATE AT THE 10 MARCH MEETING.



IN RESPONSE TO ITEM 8.5 IN THE SEPTEMBER MINUTES, DOUG TOWNSEND PROVIDED THE FOLLOWING ADDITIONAL RELATING TO E BIKES / E SCOOTERS AND TABLED FLYERS FOR THE COMMITTEE MEETING (SEE BELOW).

THE PROBLEM

THE RICHMOND POLICE DISTRICT RECOGNISES THE INCREASING PUBLIC SAFETY RISKS DUE TO ILLEGAL MODIFICATION SO OF E-BIKES AND THE UNLAWFUL USE OF E-SCOOTERS BY YOUNG PEOPLE.

THE PROACTIVE RESPONSE: "SAFETY FIRST"

DOUG HAS INITIATED THE "SAFETY FIRST" COMMUNITY EDUCATION PROGRAM IN PARTNERSHIP WITH ALL MAINSTREAM LOCAL SCHOOLS WITHIN THE RICHMOND POLICE DISTRICT TO ADDRESS THIS PROACTIVELY THROUGH DIRECT EDUCATION TO STUDENTS AND THEIR FAMILIES.



Some electric motorised bicycles known as 'e-bikes' are LEGAL to ride in public in NSW if they comply with certain CONDITIONS.



There are only two types of permitted e-bikes:

- Power-assisted pedal cycles
- · Electric power-assisted cycles

BUT they must be designed to be propelled primarily by the rider. They cannot be propelled exclusively by the motor and cannot exceed 25km/h.

Bicycles powered by electric motors are intended only to assist when riding uphill or into a headwind, NOT to be the primary source of propulsion.

Electric powered bicycles which don't comply with these conditions cannot be ridden on roads, or road related areas (such as footpaths shared paths and cycleways) in NSW, except on private land.

Anyone caught riding an illegal electric powered bicycle on a road or road-related area in NSW can face fines starting from \$723

Understanding E-Bike Rules in NSW



Some E-bikes are legal to ride in public in NSW if they comply with certain conditions:

- · All riders and passengers MUST wear approved helmets, securely fitted and fastened.
- · The electric motor must cut off when the bicycle reaches 25km/h.
- · Motors are intended to assist when riding uphill or into headwind, not as the primary source of propulsion,

E-bikes are subject to the same rules as bicycles, and have the same rights and responsibilities as other NSW road users including:

- · Keep to the left and give way to pedestrians on shared paths or footpaths.
- · Ride at a speed which is safe for you and those around you.
- · Have and use a bell to warn others you are approaching.
- · Riders are to dismount and walk across pedestrian crossings unless there is a green bicycle light,
- Only children under 16 years of age or adults accompanying a child under 16 can ride on a footpath, unless there are signs prohibiting bicycle riding.
- Mobile phones must be hands free OR secured in a commercially manufactured phone holder fixed to the bike. It is illegal to text, make video calls, use social media or take photos/videos while riding.

Penalties:

- · Fines from \$818 for illegal e-bike use.
- · Fines for not wearing an approved helmet from \$410
- · Riding under the influence of drugs or alcohol can lead to fines or imprisonment.
- On the spot fines for holding a mobile phone from \$410 $\,$
- Penalties apply for negligent or dangerous riding.

Note: If you are involved in an incident that results in injury or damage to a person's property, you may be financially liable.

Although a motorised scooter, skateboard, or hoverboard (electric or petrol powered) are considered motor vehicles, they do not satisfy the Australian Design Rules and for this reason, cannot be registered in NSW and are unable to be insured.

These devices cannot be ridden on roads, or road related areas (such as footpaths shared paths and cycleways) in NSW, except on private land.
